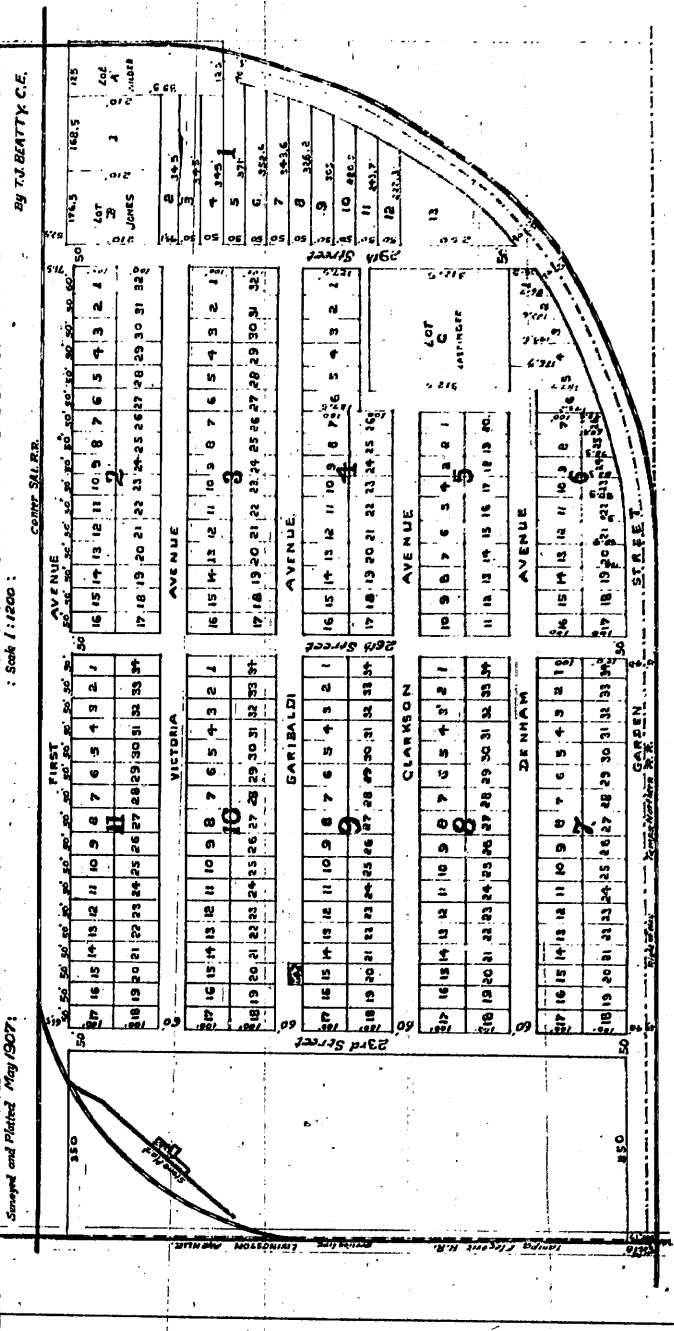
ZION HEIGHT

Hillsborough Co., Florida.

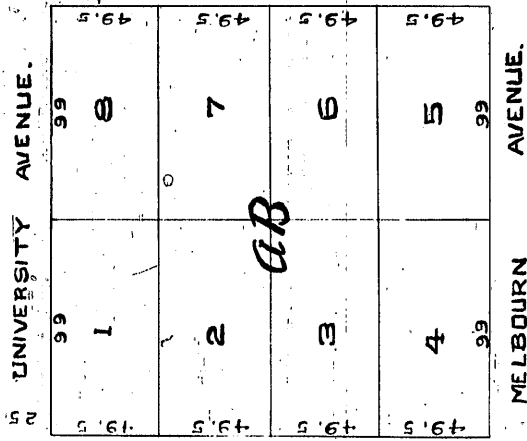
